### **Search Committee invites applications for the post of Vice-Chancellor, The Tamil Nadu Dr.Ambedkar Law University**

The Tamil Nadu Dr.Ambedkar Law University was established by the Tamil Nadu Dr.Ambedkar Law University 1996. The University offers 5 year U.G. Honours Degree Courses, P.G. Degree Courses in 9 disciplines, Research Programmes and various programmes including M.C.L. Degree Course through Distance Education Mode. 10 Government Law Colleges and 1 Private Law College in the State of Tamil Nadu are affiliated to this University.

The Tamil Nadu Dr.Ambedkar Law University Act, 1996 and amended from time to time provides for conducting a transparent and objective process of selection and appointment to the post of Vice-Chancellor.

The Hon'ble Governor of Tamil Nadu and Chancellor of this University had constituted the following Three Member Search Committee:

- The Vice-Chancellor shall be a distinguished academician with highest level of competence, integrity, moral and institutional commitment and possessing the following educational qualifications and work experience as notified by the Government of Tamil Nadu in their G.O. Ms. No.662, Law (LS) Department, dated 26<sup>th</sup> October 2017:

[1] A Ph.D. Degree in Law;

[2] Not less than twenty years of experience in teaching and research in Universities or Post Graduate Colleges or Government Law Colleges or publicly funded research institutions or in all taken together (with proof thereof);

or

Not less than ten years of experience as Professor in a University system (with proof thereof);

[3] Not less than six years of administrative experience in Universities or Post Graduate Colleges or Government Law Colleges or publicly funded research institutions in positions such as Dean, Principal, Head of the Department or any other such administrative positions of equal or higher degree of responsibility or in all taken together (with proof thereof);

- [4] Must have published not less than five research papers in the University Grants Commission listed journals after acquiring Ph.D in Law or authored not less than two books (non-edited books), if adequate number of such University Grants Commission listed journals are not available (copies of the same); and
- [5] Must have presented not less than two papers in international level academic or research events and possess experience of having conducted not less than one such academic or research event (copies of the same).
- The person appointed as Vice-Chancellor shall hold the office for a period of 3 years (provided that a person appointed as Vice-Chancellor shall retire from office; if, during the term of office, he/she completes the age of seventy years).
