CIRCULAR

With reference to the submission of Dissertation by the current Final year batch of LL.M., Degree students, I am to state that the information regarding the Dissertation component has been informed to the PG students while they join the course and it was also printed in the PG syllabus. Time and again the PG students were also informed by the faculty members to take up the Dissertation seriously and pursue the same from the completion of their first year. Further, a circular was also issued in March, 2020 asking the PG students to submit their Dissertation. However, from 16th March the PG and UG of School of Excellence in law was closed as per the directions of the Govt. of Tamil Nadu.

Subsequently, in order to safeguard the interest of College students, the MHRD, UGC and BCI issued guidelines on various dates specifying various methods to be adopted by the respective Universities, very particularly with respect to the Final years Students. In this regard, to give the benefit to the PG final year students, the Tamil Nadu Dr. Ambedkar Law University started to speed up the process of completing the internals of the PG and UG final year students so that they can have their degrees as early as possible.

With that intention a Circular was issued on 16/06/2020 wherein the Final year LL.M., Degree students were asked to submit their Dissertations in Hard or Softcopy on or before 30/06/2020. In furtherance of receiving several requests from the PG students of final year for both completing the course earlier and also for requesting extension of time to submit the Dissertation because of the Covid 19 situation, a meeting held on with all the Heads of the Departments and Controller of Examinations. In the meeting as well as in subsequent discussions, it was decided to extend the submission of Dissertations till 31/07/2020. All this things were done with the best interest of students who are at the final year of the PG studies to complete the Exam related process and to get their PG Degrees earlier.

Further, as indicated during lectures and in several meetings, the PG students shall note that, all Dissertations submitted will be processed with plagiarism software (As per the UGC Guidelines) and will be sent to the Office of Controller of Examination to verify and to fix the Viva Voce for the same.

Therefore, in superseding the circular issued on 16/06/2020, it is hereby informed that the students' who are currently pursuing their final year LL.M., degree courses shall submit their Dissertation by hard copy or soft copy by email to the concerned faculty members (Guide) on or before 30/07/2020.
