- ❖ Faculty of Law, Kalinga University, Naya Raipur organized a National Policy Making Competition on 29th October, 2022. V. Rakshana and Kenneth Moses Arul, first year LL.M students belonging to the Department of Human Rights and Duties Education, represented the School of Excellence in Law, Tamil Nadu Dr. Ambedkar Law University (TNDALU) in the event.
- ❖ The event focused to bring together the students of law on a platform where they will make and recommend policies. Participants were required to amend any existing law, or introduce any new law or policy within the ambit of these areas – Labour Law, Constitution, Criminal Law, Cyber Law, Humanitarian Law and Family law.
- ❖ Around 30 teams from across the country participated in the event. The team comprising of LL.M students from Tamil Nadu Dr. Ambedkar Law University, V. Rakshana and Kenneth Moses Arul, from the Department of Human Rights and Duties Education headed by Dr. S. Elumalai, participated and secured the first position in the event. Their write-up, which introduced amendments to the Right to Education Act of 2009, was adjudged to be the best.
