



THE TAMIL NADU DR.AMBEDKAR LAW UNIVERSITY RULES AND REGULATION SPORTS AND GAMES

About the University

The Tamil Nadu Dr. Ambedkar Law University, (TNDALU), Chennai, India was established in the year 1997, (Act No. 43 of 1997) by the Government of Tamil Nadu and it was inaugurated by the then President of India His Excellency Shri.K.R.Narayanan.

The Law University, offers legal education on its campus under the broad canopy of School of Excellence in Law (SOEL), the Law University is offering Five Years integrated B.A.LL.B (Hon's), B.Com. LL.B. (Hon's), B.B.A.LL.B. (Hon's), B.C.A. LL.B. (Hon's), and Three Years LL.B. (Hon's) Degree Courses as part of its Under Graduate Courses and 10 Post Graduate Departments offering LL.M., Degrees. The Research wing is offering Ph.D. in Law and Inter – Disciplinary studies both Full-time and Part-time. The University is South Asia's First Affiliating type Law University in India and it have its SOEL, and affiliated Law Colleges which consists of the 15 Government Law Colleges and 9 Private Law Colleges, total of 25 teams located within the State of Tamil Nadu.

Organization and Constitution

The Tamil Nadu Dr. Ambedkar Law University Sports Committee is functioning for ensuring the smooth and efficient conduct of Inter Law Collegiate tournaments and Inter University Tournaments involving all the Affiliated Government Law Colleges and Private Law Colleges Affiliated to TNDALU for the benefit of the students taking part in sport activities.

The Tamil Nadu Dr. Ambedkar Law University Sports Committee is constituted with the Vice-Chancellor as President, Registrar as Convener, Assistant Director of Physical Education as Ex-officio Secretary, Physical Directors of all the Affiliated Law

Colleges under the Tamil Nadu Dr.Ambedkar Law University, Faculty members, and Eminent Sports Persons, as members of the sports committee, as per the norms approved by the Syndicate of the University.

The Tamil Nadu Dr. Ambedkar Law University, Sports Committee is constituted to coordinate sports activities in Affiliated Law Colleges, and School of Excellence in law, and Private Law College Vitally to regulate the disciplinary activities.

2. Aims and Objectives_

- To develop the following qualities in the players of the University
- To ensure self-regulation
- To develop Personality Development
- To develop Leadership quality
- To encourage sportsmanship and competitions among the colleges involved.
- To organize Inter-Collegiate tournaments in the recognized games and sports, towards selection of University Teams.
- To raise the general standards of sports and games towards achievement in Inter-University / National / Inter-National tournaments.
- To organize the National Sports Organization programme for the total personality development of all students in order to serve the community towards its advancement.
- To develop identified talent to excellence at State, National and International levels.

3. Sports Fees

The Tamil Nadu Dr. Ambedkar Law University, affiliated law colleges shall pay a mandatory sports fee collected from students of UG/PG/Ph.D at the time of admission, as may be fixed from time to time by The Tamil Nadu Dr. Ambedkar Law University Sports Committee irrespective of the fact whether the colleges takes part or not in any of the tournaments.

The fee is to be paid in the form of demand draft drawn in favour of "The Registrar the Tamil Nadu Dr.Ambedkar Law University" and the same is to be sent along with required information.

4. Conduct of Sports & Games

The various Sports and Games are categorized depending upon the expected participation and infrastructure requirements of the Inter law collegiate tournaments.

5. University Teams

The University Team Selection Committee will select the University team based on the performance of players in the Inter Law Collegiate tournament. The selected University teams will participate in coaching camps prior to their participation in Inter-University tournaments.

6. Paralympics Sports Meet

To take care of the physically challenged students of Tamil Nadu Dr.Ambedkar Law University and its affiliated colleges who have interest in sports and games, special tournaments are organized once in a year Athletics and other games, depending on the entries received.

7. Annual Sports Award Function

The Tamil Nadu Dr.Ambedkar Law University Sports Committee organizes the Annual Sports Award Function to honor the outstanding sports persons of The Tamil Nadu Dr.Ambedkar Law University and its affiliated college with special trophies for

their achievements in Inter-University / National / Inter-National tournaments. The best performing colleges at inter law collegiate level will be honored with Championship trophies during the Award function.

8. National Sports Organization

Tamil Nadu Dr.Ambedkar Law University strives constantly in total personality development of all its students so that they can serve the community towards its advancement. In this direction, as part of UGC Regulations 2012, all the undergraduate students should enroll on admission to one of the character development Programme, namely National Cadet Corps (N.C.C.), National Social Service (N.S.S.) and National Sports Organization (N.S.O.) under the personality Character Development Programme. Over the years, we have found that these activities have brought notable changes in the attitude of students not only towards their fellow student and also towards values of life.

9. Activities of N.S.O. Students

The N.S.O programme is divided into two parts:

Regular activities

Regular Sports Classes are conducted in the evening on all working days between 4.30 p.m. to 5.45 p.m. A Comprehensive sports schedule is in practices, which includes fitness, training and coaching in various Sports & Games. It is mandatory for all the NSO students to have at least 80 hours of attendance for their active participation in an academic year.

Residential Camp

The camp is conducted for all NSO students for about ten days, during which the students are made to undergo training in specific sports and games. Activities such as Yoga, First Aid and Swimming are also given due importance. Inter-group competitions are also held during the camp to inculcate the spirit of Sportsmanship. The camp programme is generally organized during 3rd and

4th week March and April. The coaches / Experts are deputed from Sports Authority of India / SDAT and reputed institutions.

10. Intramural Sports Day

Campus intramural sports meet will commence from February/March first week every year. Students are divided into different houses. Activities including all major games will be organized in the evenings and on holidays. Track and field events will be conducted on the Sports Day which takes place usually during the month of February/March Last week every year. Sports activities for staff will also be conducted on the Sports day.

PREPARATION FOR INTER - LAW COLLEGIATE TOURNAMENTS

The schedule of the preparation work for inter-collegiate tournaments is given below in details;

- a. Initiate communication with Physical Directors and Principals of all affiliated law colleges under Tamil Nadu Dr.Ambedkar Law University about inter law college sports meet
- b. Convene Physical Directors meeting to discuss about the dates & venue of the Inter law collegiate tournaments based on the schedule of Inter University tournaments.
- c. Finalize the colleges which are willing to host the inter-collegiate tournaments.
- d. Finalize the fixtures for the Inter law collegiate sports games. In the event of unforeseen circumstances, the Fixtures for the inter law collegiate sports games are subject to change.
- e. Prepare a tentative list of members of the selection committee (for each game) for selecting University teams. The committee should have minimum three members for selecting university team.
- f. Prepare the budget estimate in connection with the conduct of Inter law collegiate tournaments.

- g. Physical Directors will act as Managers, who will be accompanying the University teams
- h. One Coach and One Manager will be permitted for a University teams.
- i. The Principals and Physical Directors have to certify the Eligibility of the players and the consolidated list of players in the format provided by University sports committee, for verification by the selection committee prior to the commencement of Inter law collegiate tournaments.

Selection Trials Norms are as follows:

Physical Directors of affiliated Law Colleges are requested to conduct internal selection at their college as per selection norms. The participants at the Divisional Level, State Level and Achievements, official recognition as annual champion tournaments conducted by SDAT/SAI/and respective official of State Association only will be accepted. Any kind of open/invitation tournaments will not be considered for selection.

The players will be selected by scrutinizing the highest achievements in each event at the International/National/State-Level. However, Participation in Open/Invitational tournaments of any kind will not be considered.

All the Physical Directors of every Law Colleges are hereby requested to select the present highest achievers in the above said events and send the certificates for scrutinizing.

"The Rules as adopted by the Sports & Games Federation of India and International sports Federation shall apply to the Inter Law Collegiate Tournament. For smooth conduct of the sports events, Organizing secretary may make changes in the rules and regulations".

GENERAL RULES

- 1. All players should wear proper Uniform.
- 2. Umpire decision is final.
- 3. All the Team should report as per scheduled time only 30 minutes grace time will be given.

- 4. All the Teams should report 15 minutes before the allotted time.
- 5. The Teams will not be allowed to play without Director of Physical Education.
 - 6. College ID card is must for all Players.
 - 7. The Team must bring the Tamil Nadu Dr.Ambedkar Law University Sports Eligibility Proforma, along with the details of players list, duly signed by the head of Institution & Director of Physical Education.
 - 8. UG students have to attach +2 mark sheets Xerox must
 - 9. PG students Degree or Provisional Certificate Xerox, +2 mark sheets Xerox must Should be enclosed.
 - 10. The Inter Law Collegiate Coordinator has rights of changing time, date & any other matter connected with Coordinator Tournaments.
 - 11. All the matches are played on League and Knockout basis.

RULES AND REGULATIONS FOR INTER LAW COLLEGIATE

SPORTS MEET

The Tamil Nadu Dr.Ambedkar Law University, Chennai the INTER LAW COLLEGIATE SPORTS MEET for Men & Women will be organized in accordance with the rules & regulation as prescribed by Sports Federations & Associations from time to time new competition rules adopted from time to time by the AIU, unless, otherwise these rules are modified.

- 1. During the INTER LAW COLLEGIATE SPORTS MEET which is to be held in the month of August, September and October, all players shall wear/carry identity card to make their presence in the sports field.
- 2. Only players alone are to be permitted in the campus and sports field during the time of INTER LAW COLLEGIATE SPORTS MEET. No outsiders shall be permitted including the near kith and kin of the players.
- 3. Smoking is strictly prohibited in the campus and sports field. Likewise no players/ even participants shall be permitted inside the campus under the influence of intoxication/drug addiction. In the event of non-compliance the deviant players will be suspended immediately and disciplinary action follows.
- 4. Under no circumstances players/participant shall be permitted inside the campus after 6 p.m.
- 5. Players should ensure that they arrive at the stipulated time to take part in the sports events. If there is any delay, the opportunity of participation in the sports events may be lost.
- 6. During the INTER LAW COLLEGIATE SPORTS MEET events and other times, no players are permitted to show gestures which deteriorate the image of others. Further players are prohibited to use derogatory words/filthy language. In the event of non-compliance, the deviant players will be suspended immediately and disciplinary action will follows.
- 7. Players shall not raise any voice which causes inconvenience to the performers/audience and Umpires/Referee during the INTER LAW

- COLLEGIATE SPORTS MEET. In the event of non-compliance, the deviant players will be suspended immediately and disciplinary action follows.
- 8. During the INTER LAW COLLEGIATE SPORTS MEET, if any disturbance causes at any point of time the entire follow up sports events will be CANCELLED immediately to prevent the untoward incidents.
- 9. During the INTER LAW COLLEGIATE SPORTS MEET all the players shall obey the instructions of the Physical Directors / organizing committee members and they have to respect them properly.
- 10. The players shall compulsorily adhere the program time schedule of events so as to enable the organizing committee to complete the events in time.
- 11. Players are permitted to use the rooms located in the stadium gallery for practice with the prior permission of the Physical Director.
- 12. During the INTER LAW COLLEGIATE SPORTS MEET if any properties of the Institution is damaged by the players, the person who caused the same is liable to pay the cost for replacement. If the person is not able to be identified by the administration, the Whole team is liable to replace the same on or before the date stipulated by the Physical Director. In the event of failure, the TC will not be issued to the players.
- 13. Players are permitted to park their vehicle only in the car park/two wheeler park area likewise they are not permitted in the no parking area.
- 14. Players/participants are instructed to maintain the campus/Field area as litter free. Therefore they are advised to keep the waste materials inside the dust bin which are kept in the campus/sports fields.
- 15. Host institutions are instructed to commence the program on time as per the INTER LAW COLLEGIATE SPORTS MEET program schedule.
- 16. No crackers shall be busted inside the campus during the INTER LAW COLLEGIATE SPORTS MEET. Lazer lights are also prohibited.

Responsibilities of the Physical Directors and Team Managers of all Affiliated Law Colleges, The Tamil Nadu Dr.Ambetkar Law University

- 1. It is the responsibility of the team manager to take utmost care regarding the safety of the players during travel/stay.
- 2. In case of emergency, he/ she should inform the Principal of their respective college.
- 3. The team manager should report about their participation in the prescribed format to the Principal of the respective colleges.
- 4. Team managers have to ensure their presence till the players are on the field.
- 5. Team managers have to monitor their players during their stay. Smoking and Drug is strictly prohibited in the rooms where the players are to be accommodated. If any damage is found in the players' accommodation room, the costs of the article/property/goods damaged have to be borne by the respective team. In the event of non-compliance of the above said rules and regulations, the deviant players will be suspended immediately and disciplinary action follows.

RESPONSIBILITIES OF UNIVERSITY TEAM PLAYERS

- 1. The players should have to necessarily obey the orders of the team managers during their travel / stay.
- 2. It is the responsibility of the University team players to keep up the name of the university by not indulging in any unwanted and unethical activities during travel / stay.
- 3. In case of the indulgence in any such activities, the matter will be viewed very seriously by team manager and the matter will be forwarded to Registrar for further action.
- 4. The players have to impart their full talent during the tournament and should exhibit the best of sportsmanship spirit.
- 5. It is recommended that if any team violates the verdict of the Umpire, the team shall be debarred from participating in any events for the subsequent one-year period.
- 6. Players have to follow the instruction of their Team Manager and Coach till the event ends.

UNIVERSITY TEAM SELECTION COMMITTEE

RESPONSIBILITIES

- 1. The members of the university team selection committee as per the direction of the Director of Physical Education Chairman, University sports committee will report at the scheduled date venue for given events.
- 2. The Committee will assist the local sports secretary in scrutinizing the eligibility of all the players participating in inter collegiate tournament, prior to the commencements of the tournament.

- 3. After selection of the university team, the chairman, University sports committee will officially announce the university team. And reserve members within a week and the list may be put up in the web site of University.
- 4. The selection committee may recommend the competency of the teams to participate in the Inter-University.
- 5. The selection of the players shall be based on the current performance but not based on past performance.
 - i. Observe all the games / matches for better identification of players.
 - ii. Assess each player position wise, if it is a team game.
 - iii. Try to collect as much information as possible of a player before hand.
 - iv. Give importance to the general discipline of a player
 - v. Be open minded and make an unbiased selection.
 - vi. The best players should be accommodated in the team.

RESPONSIBILITIES OF UNIVERSITY TEAM MANAGER

- 1. It is the responsibility of the team manager to take utmost care regarding the safety of the players during travel/stay.
- 2. In case of emergency, he/ she should inform the Registrar, the Tamil Nadu Dr.Ambedkar Law University.
- 3. The team manager should report to the Registrar about their participation report in the prescribed format.
- 4. The team manager should settle the accounts in the prescribed from within a period of 15 days

RESPONSIBILITIES OF UNIVERSITY TEAM PLAYERS

- 1. The players should have to necessarily obey the orders of the team managers during travel / stay.
- 2. It is the responsibility of the University team players to keep up the name of the university by not indulging in any unwanted and unethical activities during travel / stay.

- 3. In case of the indulging in any such activities, the matter will be viewed very seriously by university sports committee.
- 4. The players have to impart their full talent during the tournament and should exhibit the best of sportsmanship spirit.
- 5. Players have to behave respectfully while approaching any official involved in the event. Any misbehavior towards any officer during the event by the players will invite immediate suspension of their participation and disciplinary action follows.
- 6. It is recommended that if any team violates the verdict of the Umpire, the team shall be debarred from participating in any events for next year.

Subject: Revised Eligibility Rules for participation of students / athletes in National University

Games: 2017-18 onwards.

- 1. The matter with regard to revised Eligibility Rules was considered and discussed thread-bare in the meeting. Sports Board decided to adopt and approve the decision of International University Sports Federation (FISU) regarding the amendment change in "Age Limit" for participation of student athletes in FISU sporting competitions from 2017-18 Onwards. Accordingly, the new approved "Age Limit" from 17 to 25 years shall be applicable for palicipation of Indian Universities contingent/teams in all the sporting events, including the discipline of Basketball organized by the FISU.
- 2. Lot of queries have been pouring in AIU office from the member universities regarding Revised Eligibility Rules as these are mandatory for the purpose of admission and selection of teams for participation at zonal and Inter Zonal(National) tournaments.
- 3. Further, it was also decided to implement the above Age limit from 17 to 25 years along with existing "eligibility conditions" put in place for participation of bonafide and full time (regular) students, for participation in National University Games from 2017-18 onwards along with following additional terms and conditions:
- 4. Accordingly, a copy of Revised Eligibility Rules is uploaded on our website www.aiu.ac.in for advance information and necessary action of all the stakeholders Further, a copy of the same is being circulated to all member universities for advance information of all the stakeholders in due course of time

- 5. Age limit of the students shall be minimum 17 years and maximum upto 25 years
- 6. Only a bonafide, full time student, who is enrolled for a course of the University, which is of a minimum duration of one academic year, and whose examination is conducted by the university, shall be eligible to participate in the Inter-University tournaments.
- 7. Students of open Universities shall be considered to be bonafide students and shall be eligible to participate provided they fulfill other conditions.
- 8. Ph.D., M. Phil., Compartment, etc, students will be eligible to participate only if in terms of the concerned university rules they are regarded to be bonafide students and fulfil other conditions laid down in this behalf. All students participating in the Inter University Tournaments shall fulfill the following conditions:

Not more than 8 years have elapsed since a student passed the examination qualifying him/her for first admission to a university or college affiliated to a university. The 8 year period mentioned above shall be distributed as below:-

- i. Not more than 5 years after passing 10+2 or equivalent while pursuing graduate courses/studies.
- ii. Not more than 3 years after passing Graduation or equivalent while pursuing post graduate course/studies. irrespective of any other conditions like change of class/course/faculty, joining lower class from higher, changing academic to professional courses or vice versa, provided that students admitted, after passing +2 examination, to graduate courses of more than 3 years duration like Medical, Engineering, Agriculture, Pharmacy etc. shall be eligible to participate in the Inter-University tournaments for the actual length of such graduate courses/studies.
- 1. Only students, who are less than 25 years of age as on first July of the academic year in which the tournament is held, can participate.
- 2. Students shall not be full-time employees of Public or Private sector as the case maybe.

- 3. A student shall not be allowed to represent more than one University during a singleacademic year.
- 4. Provisional admission to a course or University shall not make the student eligible to represent the University.
- 5. In case of a student migrating from one University to another, his/her migration case will be considered eligible only after his/her admission in the new university is regularized and he/she is admitted as a bonafide student by the new university.
- 6. No Objection Certificate (NOC) is mandatory to be eligible for participation for those students, who received or receiving stipend/financial support for pursuing excellence in competitive sports as career from Public or Private Sector to support their studies, as the case may be.

Note: As per existing practice, the Comments and queries with regard to the Revised Eligibility Rules received from member universities, if any, will be reported to the next Sports Board Meeting for consideration.

A. Explanation:-

- 1. In case of student(s) changing from one course to another, the period spent in the previous course before joining the new course shall be counted towards total period of eligibility for the purpose of participation in National/International University Games.
- 2. One year means the academic year in which the tournament is held irrespective of whether the student's result is declared or not. It will normally extend from 1st July of one year for 12 calendar months to the next year.
- 3. A bonafide student may not be considered to be eligible to participate in National/International University Games if he/she does not pass/qualify a particular class within the period of two years, both at Graduate and Post Graduate Courses/Degrees. However, duration/length of both the courses will remain unchanged such as not more than five years after passing 10+2 examination or equivalent examination in Under Graduate Courses. Similarly, not more than four years after passing Graduate Courses while studying in Post Graduate Courses including M .Phil or Ph.D. Courses, as the case may be.
- **4.** Interchange of faculty may be allowed to participate in National/International University Games irrespective of his/her having passed the class/course but he/she should have participated only once in that particular class before seeking admission for pursuing the second one.

If the candidate participates for two years in one particular class and if he/she changes course for the identical year, he/she may not be eligible to participate in National/International University Games for the remaining period of his/her eligibility for participation in sporting events, unless he/she passes first year of the newly opted course/class, in this regard.

B. Disqualification:-

- 1. Any disqualification of a sportsperson on the grounds of ineligibility will result in automatic scratching of his/her team for that academic year. The team may be debarred from participating in National/ International University Games to be held in the following year, if necessary.
- 2. A sportsperson disqualified on the basis of ineligibility shall not be permitted to participate in National/ International University Games in the next year, if necessary.
- 3. It shall be obligatory for those players, who are selected to represent Indian Universities Team(s) in National/ International University Games. If they represent some other organization/state without permission of AIU, and their respective university/college, they shall be debarred from participation in National University Games for the period of three years and disciplinary proceedings shall be initiated in accordance with existing rules.
- **4.** It shall be mandatory for those to participate in Inter University Tournaments, students who joined Private or Public Sector(s) on nominal stipend basis only, for getting financial assistance to support/ continue their study in universities/colleges, provided their admission is based on sports quota earmarked for encouraging sports excellence in university sector.
- 5. In the case of involvement of students in incidents of violence during National/Zonal University Games, the host University authorities shall have the power to scratch their team and recommend to the concerned Universities to cancel the admission of such defaulting sportsperson(s), if found guilty after following due process of independent enquiry, in this regard.
- 6. Those sports persons who are found/tested positive on the basis of samples conducted and analyzed by NADA, confirming the use of banned drugs (doping) for enhancing their athletic performance, shall be debarred from participation in National/International University Games for the period as specified in the report of

National Anti Doping Agency (NADA) with a view to make sports drug free in university sector.

N.B. The member universities may send their comments/ observations, if any, or on the revised FISU Eligibility Rules for Participation in National/International University Games w.e.f. 2012-13 onwards, as approved by Sports Board in its meeting held on 6/6/2012, latest by 30/6/2012 for necessary action, in this regard.

- To develop the Leadership
- To encourage sportsmanship competitions among the colleges involved.
- To organize Inter-Collegiate tournaments in the recognized games and sports, towards selection of University Teams.
- To raise the general standards of sports and games towards achievement in Inter-University / National / Inter-National tournaments.
- To organize the National Sports Organization programme for the total personality development of all students in order to serve the community towards its advancement.

• To develop identified talent to excellence at State, National and International levels.

1. Membership of Players & Eligibility Rules for Participants

- 1. Only bonafide full time students who is enrolled for the UG/PG Programme as per norms of Rules and Regulation of Association of Indian University,
- 2. The eligibility rules for participants of the Inter Law Collegiate Tournaments and Inter University Tournaments. basis according to the Rules and Regulation of Association of Indian University, Students Should be less than 25 years of age as on first July of that academic year as per FISU (Federation International Sport Universities). Rules which the tournament is held, can participate.
- 3. Players of the Sports Association will be renewed every academic year.
- 4. The Best players of the Association will be allowed to represent the The Tamil Nadu Dr.Ambedkar Law University, School of Excellence in law in both National level State Level University Level and other Sports Competitions.
- 5. The players' misconduct it is recommended that if any team violates the verdict of the Umpire, the team shall be debarred from participating in any events for the subsequent one-year period.

2. <u>Team Selection Committee Members</u>

- 1. Assistant Director of Physical Education
- 2. Outside Expert in the Specified Sports & Games (Coaches)& Physical Director
- 3. Sports Committee faculty members.

3. Team Players Selection

1. Selection trials may be conducted each Sports and Games exclusively for selection of School of Excellence in law, TNDALU.

2. The selection of the players shall be based on the current performance but not based on past performance.

4. School of Excellence in law / Teams

The Team Selection Committee will select the Teams based on the performance in the Intramurals sports and selection trials, the selected teams will have to undergo coaching camps prior to their participation in the tournaments.

5. Activities of the Sports Committee

- 1. The activities of the committee shall be subject to the approval of the The Tamil Nadu Dr.Ambedkar Law University, School of Excellence in law.
- 2. Conducting students Sports and Games Tournament every year.
- 3. Conducting staff Sports and Games Tournament every year.
- **4.** The committee shall meet in every 60 days to discuss upon any proposal, amendments, announcements and suggestion to be conveyed.

6. Code of Conduct

The players of the participant in any competition should follow the code of conduct specified herein compulsorily. Failure to abide by the code of conduct or any misconduct which falls under any category of the code of conduct, shall be be taken seriously and stern action will be taken in this regard by the sports committee faculty members.

7. National Sports Organization

Tamil Nadu Dr.Ambedkar Law University strives constantly in total personality development of all its students so that they can serve the community towards its advancement. In this direction, as part of Regulations 2012, all the undergraduate students should enroll on admission to one of the character development programmes, namely National Cadet Corps (N.C.C.), National Social Service (N.S.S.) and National

Sports Organization (N.S.O.) under the personality Character Development Programme. Over the years, we have found that these activities have brought discernible change in the attitude of students only towards their fellow but also towards values of life.

Activities of N.S.O. Students

The N.S.O programme is divided into two parts:

Regular activities

(Regular Sports Classes are conducted in the evening on all working days between 4.30 p.m. to 5.45 p.m. A Comprehensive sports schedule is in practices, which includes fitness, training, coaching in Sports & Games. It is mandatory for all the NSO students to have at least 80 hours of attendance to enroll themselves in the NSO camp which will be conducted at the end of the academic year.)

• Residential Camp

The camp is conducted for all NSO students for about ten days, during which the students are made to undergo training in specific sports and games. Activities such as Yoga, First Aid, Swimming are also given due importance. Inter-group competitions are also held during the camp to inculcate the spirit of Sportsmanship. The camp programme generally organized during 3rd and 4th week May and June. The coaches / Experts are deputed from Sports Authority of India / SDAT and reputed institutions.)

8. The Sports Committee Selection of Eligibility

- 1. Only bonafide full time students who is enrolled for the UG/PG Programme as per norms of Rules and Regulation of Association of Indian University.
- 2. There shall be constituted an two Year Sports Representative from each year boys and Girls.
- 3. There shall be constituted an Team Captain from each Sports and Games boys and Girls
- 4. The Selection of the Students will be on the highest achievements any sports disciplines in a year will be considered for awarding marks.

Selection of the Year Sports Representative and Team Captain will be based on the Marks Obtained by the students, following the Guidelines given in the table.

9. Intramural Sports Day
