The Candidates who cleared the Ph.D Entrance test held on 14-2-2015 at the Tamil Nadu Dr.Ambedkar Law University are hereby informed to appear before the admission committee on 6-3-2015.

You are directed to submit a Demand Draft for Rs.2,000/- (Rupees Two thousand only) in favour of "The Registrar, The Tamil Nadu Dr. Ambedkar Law University" payable at Chennai as Registration fee.

You are also required to submit the following documents without fail at the time of appearing before Admission Committee.

- i. An outline of the **Research Proposal** intended for the thesis, in about 2000 words with a tentative chapterisation (to be produced before the Admission Committee).
- ii. Attested Xerox copy of the Master's Degree in Law & Bachelor's Degree in Law along with Mark Statements.
- iii. Attested Xerox copy of the UGC-JRF qualified certificate, if necessary.
- iv. In case of part-time Ph.D for teachers, other employers and Judges, service certificate from the institution concerned, testifying the length of service to be enclosed. In case of advocates a certificate of Bar experience from the concerned Bar Association need to be enclosed.
- v. In the case of part-time research, No Objection Certificate from the Head the Department/Institution, where he/she is employed.
- vi. A Declaration by the candidate to the effect that the candidate is not pursuing Ph.D simultaneously either as full-time or part-time scholar in any University or Research Institute. In case, if at any point of time, it is found that the candidate is pursuing a Doctoral programme contrary to the Declaration, the registration of such candidate automatically stands cancelled with immediate effect.
- vii. All the candidates should enclose the attested copy of the SSLC certificate as proof of age and date of Birth and Community Certificate.

If the candidate fulfill all the requirements, s/he is permitted provisionally to register for the Full Time Ph.D. Further it is informed that the Admission Committee will select five deserving and highly meritorious candidates for University Research Fellowships (URF).
