Dear Sir/Madam,

I have great pleasure in informing you that the Tamil Nadu Dr.Ambedkar Law University proposes to organize a One day Training Program on *The Right to Information Act, 2005"* for the SPIOs and SAPIOs.

As you are aware that "The Right to Information Act, 2005", which came into force on 13th October 2005 is a law enacted by the Parliament giving citizens of India access to information with the Central and State Governments. Awareness of this enactment is necessary not only for the ordinary citizen but also the functionaries of Public Authority by familiarizing them with the procedure for dealing with applications/appeals from the information seekers, records to be maintained, information exempt from disclosers, etc.

A balance has to be struck between the public interests and classified/sensitive information on the one hand and transparency and access to information under the public authorities on the other hand. The RTI Act of 2005 will go a long way not only in containing corruption in administration but also will make the operations of public authorities transparent.

Though the public authorities have been implementing The Right to Information Act, 2005, since June 15, 2005, yet at times, they find it difficult to process and handle the RTI applications properly and promptly. Some of the frequently faced difficult situations are enumerated hereunder:-

- ➤ Can the information seeker seek 'opinion' or 'advice' or reasons or explanations under the Act?
- ➤ If revelation of the information in actual practice is likely to come into conflict with the public interest, including efficient operations of the Government, optimum use of limited fiscal resources and the preservation of confidentiality or sensitive information, then what should the PIO do?
- ➤ How to deal with the issue of larger public interest when providing information is the "Law" and denial an "exception"?
